 - Reports on elections and on NVRA compliance received significant attention from media and served as a resource for advocates, federal and state officials, and other researchers.

- Initiated or assisted with meetings and correspondence between federal officials and coalition partners over several years resulting in renewed federal action on enforcement.
- Developed detailed technical assistance and performance monitoring plans that established best practices. These plans were adopted by several states voluntarily and serve as the basis for legal settlements in this area of law.
